## Purpose and Effect of the Consent Application

The purpose and effect of this application is to sever 1010 Heenan Court and 1020 Heenan Court which have merged on title to allow for the sale of the existing parcel at 1010 Heenan Court. The retained parcel currently has a 4-unit rental building under construction, would maintain a frontage of 72 metres (236 feet) on Heenan Court, and an area of approximately 1.39 acres. The severed parcel contains a 4-unit rental building, would maintain a frontage of 78 metres (256 feet) on Heenan Court, and an area of approximately 1.32 acres.

The effect of the proposed severance would be to create two (2) separate industrial lots on title, allowing 1010 Heenan Court to be sold.

## **Description and Location of Subject Land**

The subject lands are legally described as **Concession 4 Part of Lot 25 on Reference Plan 33R20206 Part 5** in the Township of Lucan Biddulph, County of Middlesex. The lands are located on the east side of Heenan Court, northwest of the intersection at Fallon Drive and Saintsbury Line (County Road 47). The municipal address is 1020 Heenan Court.

The Township's Committee of Adjustment will hold a public hearing to consider the consent application. The details are as follows:

If you wish to be notified of the decision of the Township of Lucan Biddulph's Committee of Adjustment with respect to the proposed consent, you must submit a written request to the Township of Lucan Biddulph, Secretary-Treasurer, 270 Main Street, Lucan, Ontario, N0M 2J0.

Notwithstanding the above, subsection 53(19) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.



## Township of LUCAN BIDDULPH


**KEY MAP**
